**Carbon County:** 0.11 miles moved to Northampton County due to calibration adjustments

**Chester County:** 0.05 miles were added from Delaware County due to calibration adjustments  
0.01 miles were added due to line relocations  
0.01 miles were removed due to centerline calibration adjustments

**Cumberland County:** 0.15 miles were moved to Dauphin County due to calibration adjustments

**Dauphin County:** 0.01 miles were removed due to centerline calibration adjustments  
0.16 miles were added from Cumberland County due to calibration adjustments  
0.01 miles were removed due to line modifications

**Delaware County:** 0.06 miles moved to Chester County due to calibration adjustments

**Juniata County:** 0.01 miles were added due to line adjustment

**Lackawanna County:** 0.11 miles moved to Susquehanna County due to calibration adjustments  
0.02 miles were added from Luzerne County due to calibration adjustments

**Luzerne County:** 0.02 miles moved to Lackawanna County due to calibration adjustments

**Northampton County:** 0.11 miles were added from Carbon County due to calibration adjustments

**Susquehanna County:** 0.11 miles were added from Lackawanna County due to calibration adjustments
