Good afternoon Your Honor,

PECO objects to the continuance request. Mr. Dodson's hearing was scheduled on February 17, 2022. Notice was provided to the Complainant via Your Honor's pre-hearing Order on December 21, 2021. PECO Energy had two witnesses ready to testify and one was pulled from field duties specifically to address Mr. Dodson's concerns. PECO has already extended resources preparing exhibits and witnesses for the hearing. It is also important to note that Mr. Dodson let me a voicemail on February 25, 2022, stating that the reason that he missed the hearing was because his son had Covid and that he

himself was in a car accident. He also stated that the reason that he did not see the hearing scheduled is because it was in his telephone and that his telephone has a new operating system and he “just missed it.” However, his email below states that his son did not have Covid and that his failure to appear was as a result of him having Covid that he contracted in late June into August. It is PECO Energy’s position that Mr. Dodson has failed to state grounds for “good cause” as required by Your Honor’s Prehearing Order.

Dear Judge,

I missed my hearing regarding my matter with PECO Energy and it seems that I had (5) days to request a continuance.

During that period not only did I have COVID there was a chance my (8) eight year old son had a bad flu but no fever. He DID NOT have COVID.

Although I was vaccinated in May, I contracted COVID in late June and into August. (I've never been so sick in all my life.)

The appointment or matter that was to face the court was in my phone, but I was in no shape to have a coherent defensible means by which to present my case.

This matter is WAY out of control. We have been charged between \$500 to \$600 per month for over two years. For a married couple and one child to incur that amount of energy was unbelievable to most every PECO Representative. Moreover, when I suggested I would go to the PUC, they backed off in a huge way and became far less aggressive.

In my opinion the error is with PECO and not our household

Therefore, being it's past the five days, am nearly begging for a continuance. This matter deserves to be heard.
