

Attached are updates for 490<sup>th</sup> Revised Page 2, 243<sup>rd</sup> Revised Page 2-A, 1<sup>st</sup> Revised Page 40-A, 1<sup>st</sup> Revised Page 40-A-1, and 1<sup>st</sup> Revised Page 40-A-3 for Forward Moving, LLC. (PA PUC Certificate #A-8920700) in Exton PA. This filing is for an **INCREASE** in local hourly Peak Season Rates, the **ADDITION** of a charge for the moving van per day, and a **CHANGE** in Full-Value Protection to \$6.00 times the weight or \$25,000.00 minimum, whichever is greater. In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles and less.

Subject to Notes 1 to 7 below, the transportation charges on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE named in Column 1 plus HOURLY CHARGE at applicable rates named in Columns 2, 3, and 4.

Hourly rates apply from the time of arrival at the first point of origin and continue during all loading, transportation from first point of origin, as well as any extra stops, to the final destination & unloading and dismissal of vehicle and men by shipper at the final destination.

Traveling charges include charges for providing truck(s) for the job and covers traveling from mover's base facility to first point of origin and returning from the final destination to the mover's base facility. Travel charge will be equal to the hourly rate based on number of men shown below.

NOTE 1 -Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3, and 4).

NOTE 2 - Hourly rates (Columns 2, 3, and 4) are based on the day or days, or period of days, as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in quarter-hour periods; fractions of one-quarter hour will be considered as one-quarter hour.

NOTE 4 - When requested by customer to hold shipment overnight, additional cost will be **\$100.00** per truck per night.

NOTE 5 - Minimum total transportation charges: Sundays and Holidays (any hour): three (3) hours at rates named in Columns 1 and 2. Monday-Friday (7:00AM to 5:00PM): two (2) hours at rates named in Columns 1 and 3. Monday-Friday (5:01PM to 6:59AM) and Saturdays (any hour): two (2) hours at rates named in Columns 1 and 4.

NOTE 6 - Any additional costs associated with the move, such as, parking fees or tolls will be added to the customer's invoice.

▲ NOTE 7 - A flat charge of **\$150.00** per moving van/truck per day per job will apply in addition to the hourly rates shown above.

In lieu of the applicable Full-Value Protection rates provided for in Tariffs Pa. P.U.C. No. 50-T (Rule 38) and Pa. P.U.C. No. 51-W (Rule 47) for the above carrier, the following rates shall apply for shipments transported between points in Pennsylvania distances of forty (40) miles and less and in excess of forty (40) miles.

▲ Full Value Protection Coverage, if requested by customer, is **\$6.00** per **\$1,000.00** of declared value of the customer's belongings with a minimum declared value based on **\$6.00** times the weight of the shipment or **\$25,000.00**, whichever is greater (customer pays a minimum premium of **\$150.00**) and a **\$150.00** deductible applies no matter what level of coverage the customer has selected. Maximum value per truck load is **\$50,000.00**. Below is a chart breaking down of how the protection is handled. When the minimum of **\$6.00** times the weight exceeds a Protection Level, the total declared value will be rounded up to the next Protection Level.
