

This filing is for the **ADDITION** of container, packing & unpacking rates (Non-Peak Season and Peak Season – both regular & overtime), an **INCREASE** in labor charges, additional transportation charge, auxiliary service, storage-in-transit & warehouse handling fees, charges for extra pickup & delivery, overtime loading/unloading, and elevator, stair carry & excessive distance fees an **INCREASE** in the minimum weight to 4,500 pounds for shipments transported in excess of 40 miles, and **INCREASE** in the handling fee, and an **INCREASE** in transportation rates (Non-Peak Season and Peak Season) for shipments transported in excess of 40 miles.
