

NOTE 2 - A flat charge based on one hour at the applicable transportation rates shown in Columns 2, 3, 4 or 5 will be assessed to cover traveling charges to and from the job when the combined distance from carrier's terminal to first point of origin and from final destination back to carrier's terminal is 30 miles or less. When the combined distance is 30 to 50 miles, a charge of 1 1/2 hours is applicable and, when the combined distance exceeds 50 miles, an additional charge based on 1/2 hour for each additional 20 miles will apply.

NOTE 3 - Rates named in Columns 2, 3, 4 and 5 apply only to 12:00 Midnight. After 12:00 Midnight, rates for the next day are applicable.

NOTE 4 - When a truck larger than 26 feet is required, add \$20.00 to the vehicle and driver rates in all columns.

▲ FULL-VALUE REPLACEMENT PROTECTION

In lieu of rates in Tristate Tariff 50-T (Rule 38) and Tristate Tariff 51-W (Rule 47), the following rates will apply:

Full-Value Replacement Protection with \$0.00 deductible is \$17.50 per \$1,000.00 of the declared value

Full-Value Replacement Protection with \$250.00 deductible is \$10.00 per \$1,000.00 of the declared value

Full-Value Replacement Protection with \$500.00 deductible is \$7.50 per \$1,000.00 of the declared value

Full-Value Replacement Protection pays for repairs to the item, or if the item cannot be repaired satisfactorily, it pays the cost to replace the damaged item.

When Full-Value Replacement Protection is purchased, the shipper must declare the value of the entire shipment (just one or two pieces or a portion of the shipment cannot be protected). The minimum coverage for Full-Value Replacement Protection is \$6.00 per pound or a total value of \$21,000.00, whichever is greater. The shipper may declare a value greater than the minimum.
