Dear Secretary Chiavetta:

On March 31, 2022, PECO Energy Company ("PECO or the Company") filed Original Tariff Gas- Pa. P.U.C. No. 5 ("Tariff No. 5") containing proposed changes in rates, rules and regulations for gas distribution service. The proposed rates are designed to produce an increase in the Company's annual distribution revenue of approximately \$81.2 million based on a fully projected future test year ending December 31, 2022. Tariff No. 5 bears a proposed effective date of May 30, 2022.

On April 14, 2022, the Pennsylvania Public Utility Commission ("Commission") Issued an Order at Docket No. R-2022-3031113 initiating an investigation of the rates, rules and regulations set forth in Tariff No. 5 and, thereby, suspending Tariff No. 5 by operation of law until December 30, 2022, unless otherwise directed by Order of the Commission. The Commission's Order also directed the Company to file a suspension supplement in the form provided as an attachment to that Order.

Therefore, in compliance with the Commission's April 14 2022 Order, PECO submits for filing with the Commission the enclosed Supplement No. 1 to Tariff Gas No. 5 to reflect the suspension of Tariff No. 5 until December 30, 2022.

Due to the continuing COVID-19 pandemic, PECO's employees are working in the office on a part-time basis. Accordingly, PECO employees will have limited access to photocopying and U.S. mail, among other services. PECO requests that all communications with PECO employees continue to be transmitted by email.
