Eric Joseph Epstein ("Epstein" or "Mr. Epstein") has been the Chairman of Three Mile Island Alert, Inc. ("TMIA") since 1985. Three Mile Island Alert is a citizens' organization founded in 1977. Mr. Epstein has served as the Chairperson and Spokesperson for Three Mile Island Alert continuously since 1984, and advocated on behalf of TMIA's gas and electric rate payers.


TMIA has provided testimony to the US Senate, the US Nuclear Regulatory Commission, the Pennsylvania House of Representatives, the Pennsylvania Public Utility Commission and have received *certificates of commendation from several governmental bodies.*

On March 11, 2022, Mr. Epstein filed a Formal Complaint with the PUC on the above docketed case. Epstein's reason for Complaint was, "To assist in achieving a balanced, equitable, and fair outcome for residential rate payers."

To resolve matters involving M. Epstein's standing. UGI has agreed to permit Mr. Epstein to testify at the Public Input Hearing on April 13, 2022 in exchange for Mr. Epstein's withdrawal of his formal complaint in this proceeding.

As such, Eric Joseph Epstein is Formally Withdrawing his Complaint, Re: UGI Rate Case: Docket No. R-2021-3030218, submitted on March 11, 2022.

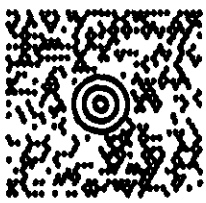

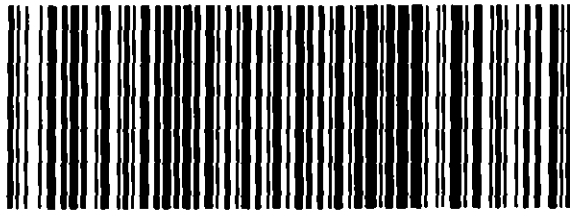
