

In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles and less.

Subject to Notes 1 to 6 below, the transportation charges on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE named in Column 1 plus HOURLY CHARGE at applicable rates named in Columns 2, 3, and 4.

Hourly rates apply from the time of arrival at the first point of origin and continue during all loading, transportation from first point of origin, as well as any extra stops, to the final destination & unloading and dismissal of vehicle and men by shipper at the final destination.

Traveling charges include charges for providing truck(s) for the job and covers traveling from mover's base facility to first point of origin and returning from the final destination to the mover's base facility. Travel charge will be equal to the hourly rate based on number of men shown below.

NOTE 5 - When a piano is included in the shipment, an additional charge per piano will apply as follows:

SPINET - **\$100.00** UPRIGHT - **\$200.00** BABY GRAND - **\$200.00** Carrier does not move grand pianos.

NOTE 6 - When a safe is included in the shipment, an additional charge per safe will apply as follows:

SAFE (up to 200 pounds) - **\$100.00** SAFE (201-300 pounds) - **\$200.00** SAFE (301-500 pounds) - **\$300.00**

Carrier does not move safes over 500 pounds. Additional charges may apply based on flights of stairs, distances, etc.

▲ NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest, TruckRouter, or similar computer software designed to calculate mileage.

For mileage in excess of 50 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.

No. 51-W (Item 115) for the above carrier, the following rates shall apply for shipments transported between points in Pennsylvania distances of forty (40) miles and less and in excess of forty (40) miles.
