RE: Community Energy Inc.; Docket No. A-110152; **NOTICE OF TRANSFER OF ELECTRIC GENERATION SUPPLY CUSTOMERS**

Dear Secretary Chiavetta:

The purpose of this letter is to provide notice to the Commission, the Statutory Parties and affected Electric Distribution Companies of the impending transfer of the residential customers of Community Energy Inc. ("CEI") to default service. CEI presently serves residential customers in the service territories of PPL, PECO, West Penn Power and Duquesne Light Co. CEI intends to assign certain of those customers to another electric generation supplier, but a limited number of contracts are not subject to that agreement and instead will be returned to default service. At this juncture, CEI does not intend to seek abandonment of its license or its ability to continue to serve customers in any service territory.

All affected customers will be notified twice via first-class mail of the impending switch, once at least 90 days before the switching is expected to commence, and again at 60 days prior to the switch. Copies of the two notices to customers are attached as **EXHIBIT A**. It is expected that customers (39 in PPL, 96 in PECO, 99 in Duquesne, and 7 in West Penn) will be switched commencing on August 2, 2022. The affected utilities are being served with a copy of this notice as well.

CEI is current with all assessments owed to the Commission, its financial security and AEPS obligations, and is current with all reporting requirements and will continue to ensure that it remains current. If there are any questions or concerns regarding this notice, please contact the undersigned.


