



NOTE 4 - Minimum Transportation Charge: Sundays and Holidays: 8 hours at rates named in Columns 1 and 2. Saturdays (any hour) or Weekdays (5:01PM to 7:59AM): 4 hours at rates named in Columns 1 and 4. Weekdays (8:00AM to 5:00PM): 4 hours at rates named in Columns 1 and 3.

NOTE 5 - Carrier will supply and charge for supervisor or supervisors as requested by shipper. Hourly rate for each supervisor will be computed from time of arrival of vehicles and men at first point of origin until completion of unloading and dismissal of vehicles and men at final destination unless other time of arrival or dismissal is provided by agreement between shipper and carrier.
