
Request for Information

- 1.) For Question #10 of the application, you are asked to describe the service area proposed by this application. For your response you stated that “to transport people between points in Philadelphia Area.” We wanted to seek clarification on what you consider to be “Philadelphia Area.” Do you mean that you only wish to transport people between points in the City and County of Philadelphia? Or do you intend to pick up and drop off in additional counties in the Philadelphia tri-state area? (ex. Montgomery, Delaware, Chester etc...) If you do wish to pick up and drop off individuals other than the City and County of Philadelphia, then you will need to identify the areas (and these areas need to have clear and defined borders that can be easily identified on a map, i.e. counties, cities, boroughs townships, etc..) that you wish to pick up and drop off individuals in addition to the City and County of Philadelphia.

To transport people between points in Philadelphia area. I am the sole owner and operator for the company ALL Transportation LLC. I get potential contract with MODIVCARE for Patient transportation. I will be transporting patients to get their medical appointments. The sence is to transport Patients working as a contractor to Modivca in Philadelphia area around the city and county of Philadelphia.

- 2.) You failed to adequately answer question #4a, b, c, d, and e of the Verified Statement of Applicant. You may wish to operate as an owner operator, but the Commission needs to know that you have an adequate structure in place should you ever choose to expand once you have been granted a certificate of public convenience. Please answer question #4a, b, c, d, and e of the Verified Statement of Applicant.
- a) Your hiring standards for drivers;
  - b) Your system for conducting criminal background checks;
  - c) Your drive training program;
  - d) Your system for conducting driver license checks;
  - e) Your policies regarding alcohol and drug use by your drivers.

I am the only driver. In the near future there is no plan to hire any drivers but if I do, I would have standared to have all prospective employees take drug test, police criminal back ground checks and safe driving skill test. Current and up to date driving record will need to be provided.
