Dear Secretary Chiavetta:

On June 2, 2021 Choice Energy LLC (“Choice”) submitted via USPS Priority Mail our 2021 Letter of Intent to Renew for Financial Security Reduction together with all required attachments, including a copy of our bond renewal for the period September 13, 2021 through September 13, 2022 as supporting documentation. Please see attached USPS Tracking ID 9205590257082100000102 with status of confirmed delivery.

On the same day of June 2, 2021 Choice submitted via separate USPS Priority Mail the “original” with “Wet Signature” the Bond Continuation Certificate and associated rider for an increase in bond amount from \$250,000 to \$350,000. Please see attached USPS Tracking ID 9205590257082100000096 with status of confirmed delivery.

On July 27, 2021 Choice received a confirmation email from Commission staff notifying Choice of its 2021 5% Annual Compliance Filing approval. Please see attached a printout of the email notice.

Finally, almost a year later on May 12, 2022, Choice received an email notice of a PA PUC docket filing of a Secretarial Letter alleging that the Bond Rider as originally filed was rejected for reason that it was a photocopy and not the original with wet ink. A copy of the May 12, 2022 Secretarial Letter is also attached for your convenience.

By way of this letter Choice affirms that, while the Bond Continuation Certificate and associated rider as submitted under USPS Tracking ID 9205590257082100000102 as supporting document to Choice’s 2021 Letter of Intent to Renew for Financial Security Reduction was a photocopy, the separately submitted Bond Continuation Certificate and associated rider as submitted under USPS Tracking ID 9205590257082100000096 was the “original” with “Wet Signature” as provided by the insurance carrier.
