On March 9, 2022, Marathon Power LLC filed a petition to reduce its bonding level from 10% to 5% of its most recent 4 quarters of revenue subject to the minimum of \$250,000, per the Commission's Order entered July 24, 2014, at Docket No. M-2013-2393141. In order for us to complete our analysis of your filing, the Energy Industry Group requires answers to the attached question(s).
