The attached pages are 502nd Revised Page 2, 3rd Revised Page 31-D, and 3rd Revised Page 31-E.



▲ **NOTE AA** - Travel charge to be based on the applicable transportation rates shown in Columns 2, and 3 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest, or TruckRouter.
