Dear Applicant:

On May 6, 2022, the Commission received the Application of **Rehoboth Paratransit, LLC**. Upon initial review, the Application has been determined to be deficient for the following reason(s):

- 1) **Your Attorney did not submit a cover letter with the Application when it was filed with the Commission. Please provide a cover letter.**
- 2) **Your description of the proposed service area is inadequate and confusing. You stated, "To transport persons in paratransit service from points in the County of Schuylkill, and return." Do you just want your proposed service area to be just the County of Schuylkill or outside of the County as well, and if so, what Counties? Please explain.**
- 3) **Please provide the names and PUC authority numbers of the taxicab and paratransit companies you have worked for in Central and Northeast Pennsylvania.**
- 4) **In Question #5, you stated that driver license checks and criminal background checks are to be done by the drivers, which is incorrect. Please explain your new system for conducting driver license checks and criminal background checks.**
- 5) **Your answer to Question #6 is incomplete. Please provide the mileage of the vehicle you intend to use for your business.**

Pursuant to 52 Pa. Code §1.4, you are required to correct these deficiencies. Failure to do so within ten (10) days of the date of this letter will result in the Application being dismissed; and, the \$350.00 application fee **will not** be refunded. You must then file a new application.
