
**Your answers should be verified per 52 Pa Code § 1.36.** Accordingly, you must provide the following statement with your responses:

Data Request

1. You are required to provide a **DATED** Statement of Financial Position which consists of information that is less than 6 months old. This information is to consist **SOLELY** of assets and debts held by Bright Eye Movers and Cleaners, LLC – **NOT** assets and debts held or attributable to corporations' individual members. For example: properties and vehicles featured on the Statement of Financial Position **MUST** be titled to the corporation; and corporate rented properties may be counted as debts, but not as assets, etc.
2. Please explain how the vehicles featured on the submitted vehicle list are appropriate for the facilitation of Statewide Household Goods in Use transportation (which is what you have requested). Of the 5 listed vehicles, all but one are small passenger vehicles which are not especially suited for the requested authority. If you intend to rent vehicles to supplement company held vehicles, please provide information relevant to that situation and please provide a detailed explanation of how you intend to verify proper maintenance of said vehicles prior to placing them into service, and also, an explanation as to how you intend to maintain records of the maintenance of said rented vehicles within your possession in the event they are requested by this Commission.
3. As stated above, in your proposed service area you have stated that you are requesting statewide operating rights; HOWEVER, in your response to Question 5 you state, “we only cover a 60 mile radius around our office- location” – please provide clarification on your proposed service area, and if requesting statewide rights, please provide an explanation as to how your assets and equipment are suitable to service an area of that scope.
4. On the FMCSA website your registration indicates a second member to your Corporation: Josiah Okpanachi,. Additionally, Mr Okpanachi has signed as a company representative in response to A-2022-3032266. Please provide an explanation as to why this person is not included in your Commission application. Also, please provide a response to Question 9 of the verified statements in regard to Josiah Okpanachi (for example, has Mr..Okpanachi ever been charged or convicted for driving without a valid license).
5. Please explain the discrepancy on the business location: on your application you only provide a Camp Hill address, yet on your website the location appears to be in Harrisburg.

Finally, you are again reminded that you are NOT permitted to provide **ANY** intrastate services for the transportation of household goods in use OR of property prior to receiving approval from this Commission. Additionally, you are not permitted to hold out to provide these prohibited services. Both are fineable offenses as was explained to you at A-2022-3032266. Presently, you maintain a website which holds out to provide service, and while you are permitted to solicit interstate moves, intrastate moves remain barred until you have Commission approval. Your website must clearly indicate that intrastate services are NOT available. **Continuing to hold out to provide prohibited services is sufficient cause to deny an application due to demonstrating a propensity to operate illegally. Compliance with this directive will be verified prior to any affirmative action on this application; failure to have complied will result in the application's denial.**
