COMPLAINT

The Pennsylvania Public Utility Commission (Commission) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement hereby represents as follows:

1. That JOSEPH RABELO-RIVERA, T/A MOVENON MOVING COMPANY Respondent, maintains a principal place of business at 202 CARLY LANE, MALVERN, PA 19355
2. On, September 10, 2021, Respondent was issued a certificate of public convenience by this Commission authorizing transportation of property for compensation at PUC utility code no. 8923526 and was advised, "*Certificate holder is advised to become familiar with the requirements of 52 Pa. Code. Failure to comply with all applicable requirements may subject the carrier to penalties, including fines suspension of operating rights or cancellation of authority. Title 52 of the Pennsylvania Code may be accessed on the World Wide Web at www.pacode.com.*"
3. On April 7, 2022, PUC Officer Reynaldo Pierluisse performed a safety fitness review of your company which resulting in an unsatisfactory rating. Officer Pierluisse tried for several weeks to contact you to perform a follow-up SFR, finally speaking to you at which time you indicated you may be cancelling your authority. The 2nd SFR was scheduled for May 10, 2022, to which you did not appear and no cancellation fomr has been received by the Commission.
4. That Respondent, by failing to achieve a satisfactory evaluation on a safety fitness review, violated 66 Ph.C.'s. §501(c) and, for failure to maintain adequate, efficient, and safe service and facilities, violated 66 Pa C.S. §1501. The penalty for this violation is cancellation of the certificate held by Respondent with this Commission at utility code 8923526.

WHEREFORE, the Bureau of Investigation and Enforcement hereby requests that the Commission revoke the certificate of public convenience of JOSEPH RABELO-RIVERA, T/A MOVENON MOVING COMPANY issued at PUC utility code no 8923526.

- C. If you file an Answer, which admits or fails to deny the allegations of the Complaint, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty.
- D. If you file an Answer which contests the Complaint, the matter will be assigned to an Administrative Law Judge for hearing and decision. The judge is not bound by the optional fine set forth above.
