Dear Attorney Marsh:

On May 24, 2022, PAWC-WD filed a letter conveying an executed copy of the Wastewater Treatment & Conveyance Agreement between PAWC-WD and York Water-WW dated May 20, 2022 (Agreement) with the Pennsylvania Public Utility Commission (Commission) pursuant to Ordering Paragraph 3(p)(ii) of the Commission’s Order entered April 14, 2022, at Docket No. A-2021-3024681 (April 2022 Order). The April 2022 Order directed that closing on PAWC-WD’s proposed transaction at Docket No. A-2021-3024681 shall be conditioned on the filing of an executed version of the Wastewater Treatment and Conveyance Agreement by PAWC-WD and York Water-WW, which is substantially similar to the version filed with the Commission on February 1, 2022 at that docket. This Secretarial Letter acknowledges PAWC-WD filed a copy of the Agreement with the Commission on May 24, 2022.

If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code § 5.44, file a petition for reconsideration from the actions of staff with the Commission within 20 days of the date this letter is served.
