Dear Secretary Chiavetta:

Enclosed please find Supplement No. 143 to Tariff Water-Pa. P.U.C. No. 14 (“Supplement No. 143”) and Supplement No. 14 to Tariff Wastewater-Pa. P.U.C. No. 1 (“Supplemental No. 14”) filed to become effective August 1, 2022. In Supplement No. 143, The York Water Company (“York Water” or the “Company”) proposes a general increase in water rates of \$18,853,738 per year, and in Supplement No. 14, York Water proposes a general increase in wastewater rates of \$1,456,792 per year. The proposed Tariff supplements are also included in Exhibit Nos. FII-3 and FII-3W of the rate filing.

On January 5, 2017, York Water filed a Petition with the Pennsylvania Public Utility Commission (“Commission”) pursuant to 66 Pa. C.S. § 1311(c) of the Public Utility Code to present combined rate filings for its water and wastewater operations in its next and subsequent filings for general rate increases. By Opinion and Order entered February 10, 2017, at Docket No. P-2017-2582839,

the Commission granted York Water's Petition. The Company is proposing to allocate a portion of the wastewater increase in this case to its water customers.

The data in support of the proposed base rate increase is based upon a Historic Test Year ended December 31, 2021, and a Fully Projected Future Test Year ending February 29, 2024, as adjusted for ratemaking purposes. On March 8, 2022, York Water requested the Commission's permission to depart from the requirements of 52 Pa. Code § 53.52(b)(2) concerning the time period between the end of the Historic Test Year and the date on which a proposed increase in base rates is filed, so that York Water would be permitted to submit this base rate filing on or before May 30, 2022. By letter dated March 10, 2022, the Commission granted York Water's request.


