
COMPLAINT

The Pennsylvania Public Utility Commission (Commission) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement hereby represents as follows:

1. That Black Tie Luxury Limousine LLC, Respondent, maintains its principal place of business at 341 Wyoming Avenue, Suite 6, West Pittston, PA 18643.
2. That Respondent was issued a letter granting transfer of certificate of public convenience for Limousine, Group and Party 11-15 authority by this Commission on December 20, 2011, at A-2012-2283000
3. On May 20, 2022, PUC Motor Carrier Enforcement Officers Neal Ebbert inspected a 2009 Chevrolet passenger van, Pa., registration number BA68540 and having Vehicle Identification No., the last four digits being 1056 to be operated by Robert Morgan on Ridgeway Drive, Dallas Township, Luzerne County, Pennsylvania, failed to display a current Pennsylvania inspection.
4. That Respondent, by permitting a vehicle to be operated in a has violated 52 Pa. §29.405. The penalty for this violation is \$250.00.

WHEREFORE, the Bureau of Investigation and Enforcement Prosecutory Staff hereby requests that the Commission fine Black-Tie Luxury Limousine LLC the sum of two hundred fifty dollars (\$250.00) for the illegal activity described in this Complaint and order such other remedy as the Commission may deem to be appropriate.



The date of service is the mailing date as indicated at the top of the Secretarial Cover Letter for this Complaint and Notice, 52 Pa. Code §1.56(a). An Answer is a written explanation of circumstances wished to be considered in determining the outcome. The Answer shall raise all factual and legal arguments that you wish to claim in your defense and must include the reference number of this Complaint. Your Answer must be verified, and the original shall be mailed to:

- B. If you fail to answer this complaint within twenty (20) days, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty. The penalty could include a fine, the suspension or revocation of your certificate of public convenience or other remedy.
- C. You may elect not to contest this complaint by paying the fine proposed in this Complaint by certified check or money order. Payment must be made to the **Commonwealth of Pennsylvania** and should be forwarded to:

- D. Your payment is an admission that you committed the alleged violation and an agreement to cease and desist from further violations. Upon receipt of your payment, the complaint proceeding shall be closed.
- E. If you file an Answer, which admits or fails to deny the allegations of the Complaint, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty.
- F. If you file an Answer which contests the Complaint, the matter will be assigned to an Administrative Law Judge for hearing and decision. The judge is not bound by the optional fine set forth above.
