Dear Secretary Chiavetta:

This letter is to inform the Pennsylvania Public Utility Commission (the "Commission") of a Natural Gas Supplier ("NGS") name change required by 52 Pa. Code § 62.105. On August 29, 2002, Dominion Field Services, Inc. ("DFS") filed a License Application to operate as a supplier, broker/marketer and aggregator of natural gas supply services in the Commonwealth of Pennsylvania pursuant to Section 2208 of the Natural Gas Choice and Competition Act (Act) and Title 52, Chapter 62, Subchapter D, at Docket No. A-125117. The Commission approved DFS's application by Commission Order entered November 21, 2002.

On or about July 14, 2017, DFS changed its name to Dominion Energy Field Services, Inc. ("DEFS") with the Delaware Division of Corporations. On or about December 21, 2020, DEFS changed its name to Eastern Energy Field Services Inc. ("EEFS") with the Delaware Division of Corporations. Accordingly, EEFS respectfully requests that the Commission change the name on the Natural Gas Supplier's License for DFS to "Eastern Energy Field Services Inc."
