Dear Applicant:

On May 10, 2022, the Commission received the Application of **Roadrunner Moving, LLC, t/a Roadrunner Moving**. Upon further review, the Application has been determined to be deficient for the following reason(s):

- 1) **You stated in Question #3 that you “have worked in the household carrier business for 7 years with Old City Movers, LLC located in Philadelphia, PA.” If so, please provide evidence of at least two years of experience with that company, as required by 52 Pa. Code §3.381(c)(1)(iii)(A)(II)(-I-). Please provide the Authority Number from the Commission for the carrier you worked with for 7 years. Also, please provide the correct name of the carrier. Old City Movers, LLC does not hold a Certificate of Public Convenience from the Commission to operate in PA.**
- 2) **Question #5 of the Verified Statement indicates technical fitness issues. It is not the responsibility of any drivers to obtain and supply their own driver’s licenses or medical certificates. Please explain your plan for obtaining the necessary and proper paperwork, should you hire other employees. Also, please state the ages of your drivers.**
- 3) **Question #7 of the Verified Statement regarding maintenance of the rental truck. You did not provide a copy of the Maintenance Plan from the rental company (Penske) for the rental truck, as requested. Therefore, you are hereby directed to supply a copy of the Maintenance Plan from the rental company, Penske.**
- 4) **After reviewing the Statement of Financial Position, you have Total Assets of \$2,425.00, and Total Current Liabilities (due within one year) of \$4,830.51. How do you intend to operate your business with a negative income balance?**

Pursuant to 52 Pa. Code §1.4, you are required to correct these deficiencies. Failure to do so within ten (10) days of the date of this letter will result in the Application being dismissed; and, the \$350.00 application fee **will not** be refunded. You must then file a new application.
