

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays: 7 hours plus applicable travel at rates named in Columns 1 and 2. Saturdays (any hour) or Weekdays, 6:01PM to 5:59AM: 4 hours plus applicable travel time at rates named in Columns 1 and 4. Weekdays, 6:00AM to 6:00PM: 3 hours plus applicable travel time at rates named in Columns 1 and 3.

NOTE 5 - Carrier will supply and charge for supervisor or supervisors as requested by shipper. Hourly rate for each supervisor will be computed from time of arrival of vehicles and men at first point of origin until completion of unloading and dismissal of vehicles and men at final destination unless other time of arrival or dismissal is provided by agreement between shipper and carrier.

NOTE 6 - When a holiday falls on a Saturday, the rates named in Columns 1 and 2 shall be applicable.

NOTE 7 - In lieu of rates shown in Freight PA. P.U.C. Tariff No. 50 and Freight PA P.U.C. No. 51, the Additional Transportation Charge, Packing/Unpacking Charges, Extra Labor Charges, and all other Accessorial Charges applicable for Beaver County will apply for all points in Pennsylvania.

▲ NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps or MapQuest.

0 - 10 miles	1/2 hour
11 - 20 miles	1 hour
21 - 35 miles	1 1/2 hours
36 - 50 miles	2 hours

For mileage in excess of 50 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.
