Your answers should be verified per 52 Pa Code § 1.36. Accordingly, you must provide the following statement with your responses:



Request for Information

- 1.) Please submit a new page 3 of your application. The specific territory should state the counties from which you expect to make trips. By stating: “from points in the Counties of _____, to points in Pennsylvania, and return” you would receive the right to go from any of the named counties, to any other county in Pennsylvania, and back. Additionally, please use specific language that will apply to ALL trips, such as non-emergency, non-medical, non-ambulance. Do not mention out of state trips, as the PUC does not regulate those, and note that PUC Authority does not give you the right to cross state lines.

- 2.) Full answers must be provided to Question 5 of the Verified Statements, whether or not you plan to use drivers in addition to yourselves.
