Dear Secretary Chiavetta:

The Pennsylvania Public Utility Commission's ("Commission") Bureau of Investigation and Enforcement ("I&E") filed a Complaint against Express Taxi LLC ("Express Taxi") seeking a civil penalty in the amount of \$650 for alleged violations of the Commission's regulations. The parties agreed to settle the matter for a payment in the amount of \$300, contingent upon Express Taxi correcting the violations alleged in the Complaint.

On June 14, 2022, the Commission received payment in the amount of \$300 from Express Taxi. On June 21, 2022, a Commission enforcement officer performed an inspection at Express Taxi's place of business and confirmed that the violations alleged in the Complaint have been corrected. The agreed upon civil penalty having been paid, and the violations having been corrected, I&E files this letter pursuant to 52 Pa. Code § 5.24(a), to certify that the above-docketed matter is satisfied and should be marked closed.


