Dear Secretary Chiavetta:

On June 16, 2022, the Commission issued an Order Directing Supplemental Information and Establishing Comment Period (“Order”) regarding Philadelphia Gas Works’ (“PGW”) Universal Service and Energy Conservation Plan (“USECP”) for 2023-2027 in the above referenced docket. The Order requires that PGW provide supplemental information in response to the questions contained in the Order within 20 days, by July 6, 2022. For the reasons discussed below, **PGW respectfully requests an extension of 15 days to provide this supplemental information by July 21, 2022.**

The Order requires PGW to submit a significant amount of detailed supplemental information. Currently, PGW has limited staff and resources available to prepare responses to these requests. Additionally, the same limited PGW staff are simultaneously involved in the proceeding regarding PGW’s USECP for 2017-2022 at Docket No. P-2020-3018867, which currently has evidentiary hearings scheduled to be held on July 13-14, 2022. Given the limited resources available and the overlap between these dockets, PGW submits that a 15-day extension will provide adequate time for PGW to provide complete responses to the Commission’s detailed supplemental information requests and will not cause unreasonable delay in the review of PGW’s USECP for 2023-2027.

Therefore, PGW requests a 15-day extension to submit supplemental information in accordance with the Commission’s June 16, 2022 Order, by July 21, 2022. Copies of this letter are being served in accordance with the attached Certificate of Service.
