# PREHEARING MEMORANDUM OF CLEVELAND-CLIFFS STEEL

Pursuant to Administrative Law Judge Joel Cheskis' June 17, 2022 Prehearing Conference Order, Cleveland-Cliffs Steel ("Cleveland-Cliffs") submits this Prehearing Memorandum.

## 1. <u>History of Proceeding</u>

On April 29, 2022, Pennsylvania American Water Company ("PAWC" or "the Company") initiated this case proposing a multi-year increase to its water and wastewater rates pursuant to 66 Pa. C.S. § 1308(d). PAWC proposes to increase rates by approximately \$154.4 million, or 21.6%. Cleveland-Cliffs filed its Petition to Intervene on May 20, 2022 and Notice of Appearance on May 25, 2022.

3. **Issues Raised by Cleveland-Cliffs** 

Cleveland-Cliffs is the largest industrial customer on the Company's system. The rates

paid by Cleveland-Cliffs for water service will be significantly affected if the Commission

approves the rate increase requested. Cleveland-Cliffs alleges that the information filed in

support of the Company's proposed rate increase is insufficient to establish that the rates to be

collected are just and reasonable. Cleveland-Cliffs also alleges that the rate structure proposed

by the Company may result in large industrial customers subsidizing other rate classes.

Cleveland-Cliffs intends to address these issues and recommend specific changes to the

Company's proposal through the testimony of its expert witness.
