Dear Secretary Chiavetta:

The Commission's June 16, 2022 Opinion and Order in this matter required Sunoco Pipeline L.P. (SPLP) to submit to the Commission payment of a civil penalty in the amount of \$51,000. On July 1, 2022, SPLP filed a Petition for Reconsideration of the June 16 Order. On July 14, 2022, the Commission granted the Petition pending a decision on the merits. Also on July 1, 2022, SPLP filed a Motion for Extension of Time and Request for Expedited Relief to extend the time for payment of the civil penalty until the Commission decided SPLP's Petition for Reconsideration on the merits and sought expedited response and relief. SPLP requested the Commission decide its Motion by July 14, 2022. SPLP also requested an expedited answer to its Motion and included the expedited time frame for response on its notice to plead. This is a common request at the Commission that has been granted in the past.

The Commission has not yet issued a decision regarding SPLP's Motion for Extension of Time. Accordingly, by this letter SPLP is requesting a temporary extension of time to submit the certified check for civil penalty until the Commission issues a decision on SPLP's outstanding Motion for Extension. Moreover, SPLP has attempted to meet the Commission's deadline, but due to delays with SPLP's bank, it will not be able to submit the check today. SPLP will submit the certified check as soon as it is able to do so if the Commission denies this additional request for extension.
