On June 23, 2022, the Commission received the Application of **Jordan R. Dietrich**. Upon further review, the Application has been determined to be deficient for the following reason(s):

- 1) **You stated in Question #3 of the Verified Statement that you are preferred and primarily recommended in the Pittsburgh area as a piano-only mover. Since you do not have USDOT Authority or PA PUC Authority, who do you work for moving pianos? Please explain?**
- 2) **You stated in Question #3 of the Verified Statement that you have decades of experience, including having trained under your father at Noteworthy Music. You also stated your father was licensed. Where was he licensed? Also, what commodities do you have decades of experience moving? Please explain.**
- 3) **Please provide evidence of a minimum of two years of experience or more with a licensed household goods carrier, or the equivalent, as required by 52 Pa. Code §3.381(c)(1)(iii)(A)(II)(-I-).**
- 4) **Please list what type of household goods you intend to transport. Also, please explain where you intend to transport the commodities, from what location to what location.**

Pursuant to 52 Pa. Code §1.4, you are required to correct these deficiencies. Failure to do so within ten (10) days of the date of this letter will result in the Application being dismissed; and, the \$350.00 application fee **will not** be refunded. You must then file a new application.
