On July 8, 2022, PPL Electric Utilities Corporation ("PPL Electric" or the "Company") served its written rebuttal testimony and exhibits in the above-captioned proceeding.

One of the Company's exhibits is PPL Electric Exhibit TE-4, which contains the reports for the Dauphin County Conservation District's ("DCCD") inspections performed on December 18, 2018, January 30, 2019, June 24, 2019, July 22, 2020, and June 10, 2021. As stated in footnote 1 on page 4 of PPL Electric Statement No. 1-R, the rebuttal testimony of Thomas R. Eby:

There was one additional inspection. PPL Electric has requested a copy of that inspection report from DCCD, but as of July 7, 2022, the Company does not have a copy of that inspection report in its possession. If and when PPL Electric receives a copy of that report, the Company will serve a supplemental PPL Electric Exhibit TE-4.

PPL Electric was recently sent a copy of that inspection report, which concerned the DCCD's inspection on October 17, 2018.

Accordingly, enclosed is a copy of PPL Electric Exhibit TE-4 (Supplemental), in which PPL Electric Exhibit TE-4 has been supplemented to include the October 17, 2018 inspection report.
