Request for Information

- a) For question #10 of the application, you are to describe the area that your service will provide. You put, “to transport people from different parts of Philadelphia as well as surrounding areas of King of Prussia to Bensalem.” Before we can continue with the application process, we will need clarification of the territory that you wish to service. The territory that you propose must have clear and defined borders that can easily be identified on a map, and King of Prussia is only a census designated area that lacks easily identifiable borders. Please clarify:
- a. Do you only intend to take people to the Township of Bensalem?
  - b. Do you intend to return these people from the Township of Bensalem?
  - c. Please clarify all areas that you wish to originate and terminate service, and do so with clear and defined borders (i.e. Boroughs, Townships, Counties, etc...).
