To Whom It May Concern:

The purpose of this Letter is to advise you that the certificate of public convenience issued on July 27, 2022, at A-2022-3031757, **was issued in error and is hereby REVOKED**. No **PARATRANSIT** transportation services may be rendered until the underlying compliance issue has been rectified; however, because this error was an administrative error, an extension of 45 days will be permitted to comply with the requirements described below.

Once the required filing is received and approved by the Commission, you will receive a re-issued Certificate of Public Convenience, with **PUC No. A-6319220** which authorizes you to begin operating under the motor carrier rights set forth in this Letter.

- a. An acceptable Form E filed by an insurance company which is evidence of bodily injury and property damage liability insurance. Your insurance company must file a Form E with the exact name of the applicant as it appears on this Letter – ALL BLUE TAXI SERVICE LLC. You should also advise your insurance company to place the following numbers at the top of your insurance form: A-2022-3031757 and A-6319220. Insurance filings are accepted online via NIC Insurance Filings at www.nicinsurancefilings.com.**

Applicants are responsible for monitoring their account online. You can do this by visiting the following web address: <https://www.puc.pa.gov/search/utility-authority-search/>. Enter your company name, click submit, then click on your utility code hyperlink. Navigate to the “Insurance Info” tab, where you can view accepted forms.

FAILURE TO COMPLY WITH ANY PROVISION OF THIS LETTER WITHIN SIXTY (45) DAYS OF THE DATE OF THIS LETTER WILL RESULT IN THE DISMISSAL OF THE APPLICATION AND REQUIRE THE FILING OF A NEW APPLICATION AND FILING FEE.

Upon issuance of a Certificate of Public Convenience you are granted the right to operate as follows:

To transport, as a common carrier, by motor vehicle, persons in paratransit service, from points in the counties of Adams, Berks, Lancaster, and York, to points in Pennsylvania, and return.

You should become familiar with the requirements of 52 Pa. Code as applicable to the **ALL BLUE TAXI SERVICE LLC**. must be reported to the Commission by filing a Change of Address Form. This form can be found on the Commission's website. Failure to comply with all applicable requirements may subject the carrier to penalties, including fines, suspension of operating rights or cancellation of authority. Title 52 of the Pennsylvania Code may be accessed at www.pacode.com.

If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code §5.44, file a petition with the Commission within twenty (20) days of the date of this Letter.
