**COMPLAINANT'S PETITION FOR LEAVE TO WITHDRAW COMPLAINT**

Complainant, Rita Seben ("Seben"), by and through her undersigned counsel, respectfully Petitions this Honorable Tribunal, pursuant to 52 Pa. Code §5.94(a), for leave to withdraw her Complaint in this proceeding without prejudice, based upon the following:

1. Seben commenced this proceeding with the *pro se* filing of a Formal Complaint against Peoples Natural Gas Company ("Peoples") regarding the re-occurring presence of natural gas odors at her residence at 133 Argonne Drive, New Kensington, PA 15068 (the "Property").
2. The hearing in this matter was conducted on April 19, 2022, before the Honorable Katrina L. Dunderdale.
3. An Initial Decision has yet to be issued as of the time of filing of the within Petition.
4. On July 8, 2022, the undersigned filed Complainant's Petition to Reopen Record (the "Petition") requesting that the record for this proceeding be re-opened to permit Seben to proffer certain videos and/or other information involving Seben's purchase and use of a methane gas detector on the Property into evidence.
5. Since the time the Petition was filed, Peoples has performed certain work on the Property and such work, as of this writing, appears to have alleviated the natural gas odors which were the reason why the Complaint against Peoples was filed by Seben.

6. Therefore, pursuant to 52 Pa. Code §5.94(a), Seben respectfully requests that this Honorable Tribunal grant her leave to withdraw her Complaint without prejudice.

7. A Call-In Telephone Hearing Notice, dated July 21, 2022, was issued in this matter scheduling such a telephonic hearing to be conducted on Thursday, August 21, 2022, starting at 10:00 a.m.

8. Seben further respectfully requests that that telephonic hearing be cancelled.
