Payment of Civil Penalty (Without Prejudice)

Dear Secretary Chiavetta:

The Commission's June 16, 2022 Opinion and Order in this matter required Sunoco Pipeline L.P. (SPLP) to submit to the Commission payment of a civil penalty in the amount of \$51,000. On July 1, 2022, SPLP filed a Petition for Reconsideration of the June 16 Order. On July 14, 2022, the Commission granted the Petition pending a decision on the merits. Also on July 1, 2022, SPLP filed a Motion for Extension of Time to extend the time for payment of the civil penalty until the Commission decided SPLP's Petition for Reconsideration on the merits and sought expedited response and relief.

The Commission has not yet issued a decision regarding SPLP's Motion for Extension of Time. Accordingly, SPLP is submitting the enclosed penalty payment. SPLP respectfully requests that the Commission hold the enclosed penalty check until a decision is issued regarding SPLP's Motion for Extension of Time. Should the Commission grant SPLP's Motion for Extension of Time, SPLP requests that the civil penalty check be returned in the enclosed envelope. To the extent the Commission cashes the check prior to making a decision on the merits of reconsideration, SPLP notes it is submitting the enclosed civil penalty payment under protest, without prejudice, and reserving all rights to appeal the Commission's June 16 Order.

Counsel for SPLP is serving a copy of this letter on Complainant's counsel.
