Request for Information

- a) Upon reviewing your reply to the Commission’s data request, we had a couple of questions that need clarification before we can continue with the application process. On your application you mentioned that you wished to offer transportation in “surrounding areas of King of Prussia to Bensalem.” However on your reply to the Commission’s data request, you only mentioned that you would be providing transportation between points in the County of Montgomery (specifically the Boroughs of Jenkintown, North Wales, and Hatboro, the Township of Abington Township)[Willow Grove was also mentioned, but is only listed as a Census Designated area, and as such does not meet our standard for a clear and defined area that can easily be identified on a map], and the City and County of Philadelphia.
- a. Do you also intend to offer service to the areas of King of Prussia (Upper Merion Township) and the Township of Bensalem Township (which is located in Bucks County). Or do you only intend to offer transportation between points in Montgomery County, and the City and County of Philadelphia.
- b) Based on the aforementioned information provided, it would appear that your territory should be written as one of the following:
- a. To transport people in paratransit service between points in the Montgomery County and the City and County of Philadelphia.
 - b. To transport people in paratransit service between points in the Boroughs of Hatboro, Jenkintown, North Wales, and the Township of Abington Township, all located in Montgomery County, and the City and County of Philadelphia.
 - c. To transport people in paratransit service between points in the Boroughs of Hatboro, Jenkintown, North Wales, the Townships of Abington Township, Upper Dublin, and Upper Moreland (**Willow Grove is located in these 3 townships, so if you wished to include it this would how it would be written**), all located in Montgomery County, and the City and County of Philadelphia.

The three options above (a-c) would be how you we would write up the proposed territory if you do not wish to include King of Prussia

(Upper Merion Township) and Bensalem Township. If you do wish to service to these areas, then we would either add Bucks County, or add Upper Merion Township and Bensalem Township, Bucks County to the aforementioned Townships. Please review the options above and let us know which option covers the territory you wish to service, and whether or not you wish to also include the King of Prussia area (Upper Merion Township) and Bensalem Township. If none of these options cover your proposed territory, then please list in great detail the territory you wish to service, and please do so in a way that has clear and defined borders that can easily be identified on a map.
