Request for Information

- 1.) Question #10 of the Property application asks “What type of commodities do you intend to transport other than your own? Please not applicable exemptions on pages 4-5.” You said, “Household Goods.” A Certificate of Public Convenience for Property rights grants you the following right: “To transport, as a common carrier, by motor vehicle, **property, excluding household goods in use**, between points in Pennsylvania.”
 - Please list the commodities that you intend to transport (excluding household goods in use). Normally we would also ask that you to file an application for Household Goods in Use rights if you intend to transport household goods, but we see that you also have filed an application for said rights.

- 2.) The application’s “Verification of Application” statement is signed by a Marrissia Axel. As stated below the Signature line, “The verification of the application must be completed by the applicant appearing on Line 1 of the application by the named individual, all partners if a partnership, **a member (if a limited liability company)**, or by the President or Secretary (if a corporation).”
 - Marrissia Axel is not listed amongst the members of LLC. Please refile the application with the information from question #1 of this data request, and signed by one of the members of the LLC.

FYI if your other application for Household Goods in Use rights is also signed by Marrissia Axel, then it to will need to be corrected as well.
