

NOTE 6 - In lieu of rates for packing and unpacking labor in tariffs, Tristate 50-T and Tristate 51-W, carrier will provide packing and unpacking labor using the hourly shown on Pages 23-C-1 and 23-C-2. The applicable travel time charge will apply in addition to the hourly rates.
