On August 12, 2022, the Pittsburgh Water and Sewer Authority (“PWSA”) filed a Cost Sharing and Restoration Work Agreement (“Agreement”) among PWSA, Peoples Natural Gas, and Duquesne Light Company (“Duquesne Light”) via overnight mailing. As of the date of this letter, the Commission has not assigned a docket number to PWSA’s August 12, 2022, filing.
