- a. An acceptable <u>Form E</u> filed by an insurance company which is evidence of bodily injury and property damage liability insurance. Your insurance company must file a Form E with the exact name of the applicant as it appears on this Letter – LAUSCH'S MOVING COMPANY. You should also advise your insurance company to place the following numbers at the top of your insurance form: A-2022-3033557 and A-8925351. Insurance filings are accepted online via NIC Insurance Filings at www.nicinsurancefilings.com.
- b. An acceptable Form H filed by an insurance company which is evidence of bodily injury and property damage liability insurance. Your insurance company must file a Form E with the exact name of the applicant as it appears on this Letter LAUSCH'S MOVING COMPANY. You should also advise your insurance company to place the following numbers at the top of your insurance form: A-2022-3033557 and A-8925351. Insurance filings are accepted online via NIC Insurance Filings at www.nicinsurancefilings.com.
- c. Email tariff draft to: <u>RA-PCTARIFFFILING@pa.gov</u>. DO NOT E-File unapproved tariffs. Call (717) 214-7155 for assistance.

Applicants are responsible for monitoring their account online. You can do this by visiting the following web address: <u>https://www.puc.pa.gov/search/utility-authority-search/</u>. Enter your company name, click submit, then click on your utility code hyperlink. Navigate to the "Insurance Info" tab, where you can view accepted forms.

## FAILURE TO COMPLY WITH ANY PROVISION OF THIS LETTER WITHIN SIXTY (60) DAYS OF THE DATE OF THIS LETTER WILL RESULT IN THE DISMISSAL OF THE APPLICATION AND REQUIRE THE FILING OF A NEW APPLICATION AND FILING FEE.

Upon issuance of a Certificate of Public Convenience you are granted the right to operate as follows:

To transport, as a common carrier, by motor vehicle, Household Goods in Use, between points in Pennsylvania

You should become familiar with the requirements of 52 Pa. Code as applicable to the **LAUSCH'S MOVING COMPANY**.. must be reported to the Commission by filing a Change of Address Form. This form can be found on the Commission's website. Failure to comply with all applicable requirements may subject the carrier to penalties, including fines, suspension of operating rights or cancellation of authority. If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code §5.44, file a petition with the Commission within twenty (20) days of the date of this Letter.
