Dear Secretary Chiavetta:

For nearly a decade, I have attempted to help the customers of the East Dunkard Water Authority (EDWA) receive safe and clean drinking water. Unfortunately, the former EDWA board members rejected assistance at every turn, insisting they could repair the treatment plant. After all these years, the current customers are still dealing with water quality issues, and have faced several weeks of Boil Water Advisories from the Department of Environmental Protection just in the last year.

Finally, EDWA is under new management with a brand-new board of directors ready to take on this Goliath task to provide clean drinking water to local residents. This group of passionate public servants have faced adversity at every turn. With a declining customer base that is already in a low-income area, EDWA is significantly cash-strapped to make the improvements needed. In May, I helped Greene County secure a \$2 million Community Development Block Grant (CDBG) to begin work on the authority's system, and I have supported congressionally directed spending initiatives for the authority.

The authority has begun conversations with the Southwestern Pennsylvania Water Authority for a potential takeover, or the purchase of water. Even still, any takeover or partnership is years away. These EDWA customers need clean water now, and these funds will allow for temporary fixes to improve their water quality until they can afford a long-term solution.

It's my understanding that EDWA is facing a potential fine from the Public Utility Commission for administrative paperwork failures. While I have been critical of the past leadership of EDWA and asked for action to be taken, this fine now will significantly impact the progress that has been made in the past year. EDWA needs every penny available to them to invest into their water system to provide safe drinking water to their customers.
