**PHILADELPHIA GAS WORKS' MOTION TO CONTINUE**

1. By notice dated July 20, 2022, the Commission scheduled a telephonic hearing in this matter for Thursday, September 8, 2022 at 10:00 a.m., before Administrative Law Judge Marta Guhl.
