Dear Secretary Chiavetta:

On August 4, 2022, the Pennsylvania Public Utility Commission ("Commission") approved the Joint Petition for Approval of Settlement between the Commission's Bureau of Investigation and Enforcement ("I&E") and Peoples Natural Gas Company LLC ("Peoples") in the referenced docket number. The Commission's Opinion and Order requires Peoples to take the following actions:

- 1. remit a civil penalty of \$195,000;
- 2. provide the I&E's Safety Division with the list of all current temporary meter and regulator stations in Peoples' system;
- 3. change its design process with regard to temporary meter and regulator stations to ensure that all of the requirements of 49 CFR Part 192 are met; and
- 4. implement a process to consult with I&E's Safety Division in the event that Peoples is uncertain whether a situation would be considered a reportable incident.

As pursuant to 52 Pa. Code § 5.591, Peoples is filing this notice of its compliance with the requirements set forth in the Commission's Opinion and Order. On August 30, 2022 Peoples sent a certified check in the amount of \$195,000.00 to you by overnight mail. Also, on August 30, 2022, Peoples sent by e-mail a list of all of its temporary meter and regulator stations, certain changes to its job procedures and design process with respect to temporary meters and regulator stations and also the procedure by which Peoples will consult with I&E's Gas Safety Division in the event of any future incidents.
