To Whom it May Concern:


On March 10, 2022, the Commission entered a Tentative Order, Docket No. M-2022-3031036, which advised Keep It Moving LLC that it was not in compliance with the insurance requirements of 66 Pa.C.S. § 512. The Tentative Order advised Keep It Moving LLC, that it must, within 30 days of publication of the Tentative Order, either have acceptable evidence of insurance filed with the Commission or cancel their authority or file comments to the Tentative Order. The Tentative Order advised Keep It Moving LLC, that, if it failed to respond, its certificate of public convenience would be cancelled. The Tentative Order was served on Keep It Moving LLC and published in the *Pennsylvania Bulletin*.

Keep It Moving LLC failed to respond to the March 10, 2022, Tentative Order and is currently non-compliant with the insurance requirements of the Public Utility Code at 66 Pa.C.S. § 512. Additionally, the Respondent no longer has a tariff on file with the Commission, as required by 66 Pa.C.S. § 1302, and it has come to our attention that the Respondent has abandoned service without first filing an application with the Commission, by doing so he has violated 52 Pa. Code § 3.381(a)(1)(v) and 66 Pa. C.S. § 1102(a)(2). Respondent has also failed to file assessments for the calendar year of 2018, 2019, 2020, and 2021, and has an unpaid assessment balance of \$154.00.

Furthermore, this Commission will request the Pennsylvania Department of Transportation to put an administrative hold on Respondent's vehicle registrations. Respondent will **NOT** be able to register any new vehicles or renew any existing vehicle registrations until a new application for authority is submitted.

YOU ARE ADVISED: That the certificate(s) issued at Docket No. A-2017-2617127 be and is hereby *cancelled*, and all rights, powers, and privileges granted thereby shall forthwith cease and terminate.
