
COMPLAINT

The Pennsylvania Public Utility Commission (Commission) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement hereby represents as follows:

1. That ABUNDANTLY BLESSED HOME CARE, LLC, Respondent, maintains a principal place of business at 2910 Edgmont Avenue, Brookhaven, Pennsylvania, 19015.
2. On December 8, 2021, Respondent was issued a certificate of public convenience by this Commission authorizing transport, as a common carrier, by motor vehicle, persons in paratransit service, from points in the City and County of Philadelphia, to points in the counties of Bucks, Chester, Delaware, and Montgomery, and return at PUC utility code no. 6423768. Information contained in that letter "Certificate holder is advised to become familiar with the requirements of 52 Pa. Code. Failure to comply with all applicable requirements may subject the carrier to penalties, including fines suspension of operating rights or cancellation of authority. Title 52 of the Pennsylvania Code may be accessed on the World Wide Web at www.pacode.com."
3. Between April 25, 2022, through August 8, 2022, PUC Enforcement Officer Melissa Vickers attempted several times to contact Respondent by phone. Certified and first-class mail letters was sent to Respondent on April 25, 2022, requesting Respondent contact Officer Vickers to schedule the safety fitness review within ten days. The USPS tracking system indicates the certified letter was delivered on April 30, 2022. A second first-class mail letter was sent to the Respondent on June 6, 2022. Respondent has not contacted the district office.
4. That Respondent, by failing to achieve a satisfactory evaluation on a safety fitness review, violated 66 Pa. §501(c) and, for failure to maintain adequate, efficient, and safe service and facilities, violated 66 Pa. §1501. The penalty for this violation is cancellation of the certificate held by Respondent with this Commission at utility code 6423768.

WHEREFORE, the Bureau of Investigation and Enforcement hereby requests that the Commission revoke the certificate of public convenience issued Abundantly Blessed Home Care, LLC, at PUC utility code no. 6423768.



The Answer shall raise all factual and legal arguments that you wish to claim in your defense and must include the reference number of this Complaint. Your Answer must be verified, and the original shall be mailed to:

- B. If you fail to answer this complaint within twenty (20) days, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty. The penalty could include a fine, the suspension or revocation of your certificate of public convenience or other remedy.
- C. If you file an Answer, which admits or fails to deny the allegations of the Complaint, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty.
- D. If you file an Answer which contests the Complaint, the matter will be assigned to an Administrative Law Judge for hearing and decision. The judge is not bound by the optional fine set forth above.
