Pursuant to 66 Pa.C.S. §2101 *et. seq.*, Duquesne Light Company (“Duquesne Light” or “Company”) hereby files for approval the attached Affiliate Services Agreement (“ASA”) between The Efficient Network (“TEN”) and the Company. The proposed Construction Master Service Agreement is enclosed and marked CONFIDENTIAL ATTACHMENT A. The related Statement of Work is enclosed and marked CONFIDENTIAL ATTACHMENT B. Duquesne Light respectively request that Attachments A and B be treated as confidential and protected from public disclosure as they contain competitive information.

Upon Pennsylvania Public Utility Commission approval of the enclosed contract, TEN will replace up to 50,000 Duquesne Light owned high pressure sodium streetlights with LED fixtures and smart nodes which will be provided by Duquesne Light. TEN was selected for this project via competitive procurement process. A total of five entities participated in the competitive solicitation process. TEN was the winning bidder based on cost and technical score. Approval of the ASA is in the public interest as TEN is highly qualified with direct experience completing similar projects for other entities. Additionally, approval of the ASA will result in lower costs for Duquesne Light customers as compared to other bids.


