Your answers should be verified per 52 Pa Code § 1.36. Accordingly, you must provide the following statement with your responses:



Request for Information

- 1) Based on the information you provided, it would appear you filled out the incorrect application. The application filed, was for Group and Party 15 or less service. Group and Party 15 or Less authority type is for vehicles that hold 11-15 passengers including the driver. Includes special excursions and tours with no individual charges.

Important note: Group and Party service originating or terminating in Philadelphia City is under jurisdiction of the Philadelphia Parking Authority, and an application must be filed with that agency to operate there.

The information provided in the application indicates your intention is to provide Paratransit service. Paratransit authority type is for vehicles holding 16 or fewer passengers including the driver. This authority type includes Amish taxis, non-ambulatory services, medical transportation, and prison visits with individual charges.

In response to this data request, you will need to complete and e-file an application for Paratransit service. You must indicate you want to amend your authority to Paratransit service at A-2022-3035109, for authority number A-6425540. Please review the Commission's Paratransit operations and provide an explanation as to why your service should be considered under the Group and Party 15 or less service. The explanation should include, but not limited to: how will the passengers be charged? Do you plan to operate in the City of Philadelphia?

- 2) Based on the aforementioned information provided, it appears you are pursuing Paratransit service and your territory on **question 10** of the paratransit application maybe written as one of the following:
 - a) To transport persons in Paratransit service between points within the City and County of Philadelphia. (Allows you to pick up and drop off within the City and County of Philadelphia).
 - b) To transport persons in Paratransit service from points in the City and County of Philadelphia to points in Pennsylvania and return. (Allows you to pick up in City and County of Philadelphia and transport to points in Pennsylvania and return them to points in the City and County of Philadelphia).

Please review the above information and examples to clarify on the Paratransit application the proposed area of service that you intend to provide, keeping in mind the Commission's criteria for said area.
