On behalf of Reliant Energy Northeast LLC ("REN"), please accept this Annual Compliance Filing to renew its required level of financial security at the reduced level of 5% of its most recent twelve months of revenue. This Annual Compliance Filing is being submitted at least 90 days prior to the anniversary date of REN's current financial security. REN provides the following information and documentation in support of its Annual Compliance Filing:
