On September 8, 2022, the Commission received the Application of **Champion Marketing Corp., t/a CMC Transportation**. Upon initial review, the Application has been determined to be deficient for the following reason(s):

- 1) Your description of the proposed service area is inadequate and unacceptable. Where is the service to originate? Are you only operating between the four counties you listed, or to points in PA and return?**

To transport, as a common carrier, by motor vehicle, persons in Paratransit service, from points in the counties of Westmoreland, Washington counties, to points in Pennsylvania, and return. We will provide non emergency medical transportation taking people to various appointments. We are interested in doing contracting.

- 2) Question #4 of the Verified Statement of Applicant is not answered in its entirety. Please describe your physical location and the facility to house your vehicles.**

We are located in the business district of Monessen, PA and we will park near are building but we are currently working with a contact to find a lot near by. The business has an upstairs and a downstairs. We will start off working on floor two as the bottom is being renovated.

- 3) Question #5 of the Verified Statement of Applicant indicates you intend to hire drivers that are 18 years of age, which is incorrect. All drivers must be at least 21 years of age for a clean 3-year driving record.**

We would like to correct are statement about the age of the drivers. Drivers will be at least 21 years of age. We have also made a correction to our driver vetting policy. We have removed American Logistics out of our language in that document. Please note that we have contacted a consortium and they will take care of all our drug testing

needs. We will wait for approval before we enroll. They are called Nationwide Testing (NTA).

CMC will follow all PUC rules and regulations when it comes to driver vetting.

**4) Question #6 of the Verified Statement of Applicant asks that you fill in the vehicle chart if you have already obtained vehicles for your business. You stated you have purchased 2 vehicles. The vehicle chart must be completed.**
