**REQUEST FOR REFUND AND COMPLIANCE CONFIRMATION**

Dear Secretary Chiavetta:

Sunoco Pipeline L.P. (SPLP) previously submitted a check to the Commission in the amount of \$51,000 for payment of a penalty required by the Commission's June 16, 2022 Opinion and Order in this proceeding. In its September 13, 2022 Opinion and Order on Reconsideration, the Commission granted SPLP's request for reconsideration of the June 2022 Order in part, reversed its prior findings of penalties associated with \$48,000 of the penalty issued in the June 2022 Order, and modified the penalty to \$3,000.

For efficiency, SPLP respectfully requests the Commission issue a refund check for \$48,000 and retain \$3,000 from the original penalty payment in satisfaction of the September 2022 Order. Please make the \$48,000 refund check payable to Sunoco Pipeline L.P. A copy of this letter will be mailed to the Secretary's Bureau along with a self-addressed stamped envelope for transmittal of the check to our office.
