On September 16, 2022, the Commission received the Application of **Northeastern Movers, Inc.** Upon further review, the Application has been determined to be deficient for the following reason(s):

- 1) **You filed an Application for Motor Common Carrier of Household Goods in Use only; however, upon further investigation, you are also transporting property. On your website: <https://northeasternmovers.com/services/piano-moving/>, under the heading, BEST LOCAL PIANO MOVERS IN THE AREA, you state residential customers can call you to move a piano to a new home within Scranton, and you also state that commercial customers such as churches, schools, music studios, hotels, colleges, and senior living centers, and many more, can also call you to move pianos. You state you can also pick up a newly purchased piano if delivery was not included, or you can relocate a piano on the grounds or to an entirely new property. Also, under the heading, LOCAL MOVING SERVICE (RESIDENTIAL & LOCAL MOVING COMPANY), FULL-SERVICE LOCAL AND RESIDENTIAL MOVING COMPANY, you also state that you provide full-service local and residential moves for families. Please explain these moves. Where do these moves originate? Where do they end? Please include exact locations.**
- 2) **Question #4 of the Verified Statement of Applicant has not been answered in its entirety. Please include an explanation of your plan to maintain records required by the PUC, as well as normal business records. In regard to your communication network, please explain how you will receive customer requests for transportation, how you will dispatch the vehicles to fulfill the request, and how you will maintain continuous communication with your drivers. Please explain your plans.**
- 3) **Question #6 of the Verified Statement of Application asked for a Vehicle ID Number (VIN) for each vehicle listed. The numbers you listed are incorrect. Please provide the correct information.**

- 4) **The Statement of Financial Interest indicates that there is a financial fitness issue. Under Current Assets, you have \$1,000.00 in cash assets. Under Other Current Assets (specify), you have \$43,965.00. Under Current Liabilities (Due within one year of date), you owe \$1,000.00 for a Loan, and \$34,563.00 for Credit cards/revolving credit. Under Long Term Liabilities (Due after one year of date), you owe \$200,000.00 for a Long-Term Commercial Loan. Your Total Liabilities are \$244,563.00. You state that your Company has been grossing close to 2 million dollars consistently for the past two years; however, your account only shows \$1,000.00 in Current Cash Assets. What are the terms of your loans and credit cards? What are Other Current Assets (specify)? Please explain.**

Pursuant to 52 Pa. Code §1.4, you are required to correct these deficiencies. Failure to do so within ten (10) days of the date of this letter will result in the Application being dismissed; and, the \$350.00 application fee **will not** be refunded. You must then file a new application.
